Major research interests and research leadership:

From the beginning of my doctoral research in 1975 until about fifteen years ago, my work centred on intonation and prosody. My doctoral thesis on intonational meaning was the source of the now standard terms 'broad focus' and 'narrow focus', and my 1981 paper on negative questions has recently inspired considerable discussion in formal semantics. Since the early 1980s, though, my prosody research has dealt primarily with phonological and phonetic questions. In the early 1990s I was an outside consultant in the discussions that led to the formulation of the original ToBI standard for prosodic transcription of English. A specific focus of my own work has been the search for evidence of the existence of localised targets in pitch contours, including the questions of how such targets are scaled relative to the speaker's voice range and how they are temporally coordinated with the segmental string. With regard to the last of these, my work with Amalia Arvaniti and others established the notion of 'segmental anchoring', which was a focus of research in the first decade of this century. My book Intonational Phonology rapidly became a key text on intonation after the first edition appeared in 1996, and since the publication of the second edition in 2008 it is now, according to Google Scholar, the single most widely cited source in the field. A Chinese translation (语调音系学) appeared in summer 2022.

More generally, throughout my career I have been active in promoting the approach known as 'Laboratory Phonology', which aims to make instrumental and experimental data an integral part of theoretical work on phonology and to treat theoretical issues in phonology as a basis for experimental research in phonetics and psycholinguistics. In the late 1980s I played a role in establishing the Laboratory Phonology conference series and ensuring that it became international. I was elected as the first president of the Association for Laboratory Phonology when it was founded in 2010 and served in this role until July 2014.

Since about 2000 my research has increasingly dealt with broader questions about phonology and about language more generally. My book *Simultaneous Structure in Phonology* (2014) brings together several strands of this work with my lifetime work on prosody and intonation. I have also developed several specific topics in the past two decades, mostly in collaboration with various colleagues. For example, two AHRC-funded projects on Dinka (a language of South

Sudan), in collaboration with my Edinburgh colleague Bert Remijsen and others (2005-2012), have led to publications on topics well beyond the specific focus of the grants. The first project was the basis of a discussion note in *Language* (2009) on the implications of Dinka noun morphology for Pinker's 'dual-route' notion of irregularity; with Mirella Blum, a student of Bert Remijsen's, I revisited this topic in 2020 and the resulting reconsideration of Dinka irregularity appeared in *Journal of African Languages and Linguistics*. (A further collaborative paper with Blum on Dinka noun morphology is in preparation.) The second project has led me into research on musical text-setting in tone languages, which was the subject of an AHRC Early Career Fellowship (2015-16) held by my Edinburgh colleague James Kirby, with me as named mentor. Another issue – the problem of "quasi-contrastive" distinctions – lies behind a couple of other recent collaborative publications, one with Peggy Renwick of the University of Georgia on Italian mid vowels and one with Stephan Schmid of the University of Zurich on aspirated stops in Swiss German. The latter study is part of an ongoing interest in segmental influences on fundamental frequency that includes further collaborative work with James Kirby (e.g. *JASA* 2016, doi: 10.1121/1.4962445) and with my Zurich colleagues (in preparation).

In 2007 Dan Dediu and I published a paper in Proceedings of the National Academy of Sciences (PNAS) showing that the uneven geographical distribution of different variants of two human genes involved in brain development is mathematically correlated with the uneven geographical distribution of tone languages. We proposed that the relationship is mediated by a 'cognitive bias' attributable to the genetic differences, which affects the transmission of language over many generations (more detail can be found here). Subsequently Patrick Wong published a study directly motivated by our paper (Wong et al., PLoS-1, 2012), reporting response differences to linguistic pitch that are correlated with one of the two genes we discussed. Our own follow-up work focused on individual differences in pitch perception, including a study published in Journal of Experimental Psychology: Human Perception and Performance in 2013. From 2012 to 2017 Dediu directed a five-year Dutch Research Organisation (NWO) "Vidi" postdoctoral grant entitled "The influence of genetic biases on the evolution, universal properties and diversity of speech and language" at the Max Planck Institute for Psycholinguistics in Nijmegen; he is now a Research Professor at ICREA at the University of Barcelona. Most recently Wong has published another study whose results are much more directly in line with the original Dediu/Ladd proposal: we discuss the details in a paper we posted on PsyArXiv.

I was a member (2006-2013) of the *Fachbeirat* (Scientific Advisory Council) of the Max Planck Institute for Psycholinguistics, Nijmegen. Main responsibility was participation in biennial site visits, following which we provided in-depth reports on the Institute's work directly to the President of the Max Planck Society.

From the mid-1980s until 2010 or so I regularly reviewed 2-4 research proposals a year for various funding bodies in a number of countries, especially the ESRC, AHRC, and British Academy, the US National Science Foundation, the Canadian Social Science and Humanities Research Council, and the German Research Foundation (Deutsche Forschungsgemeinschaft).

I have twice served as an outside reviewer for the German Research Foundation on the establishment of special research funds (*Forschungsschwerpunkt*), one on intonation (1981-1988) and one on laboratory phonology (2006-2012). This involved evaluating both group and individual proposals and occasional involvement with group meetings and workshops. In 2013 I served on a similar panel for a special research programme for the Volkswagen Foundation.

I was the outside evaluator of a major four-year interdisciplinary research programme on prosody (1998-2002), University of Geneva, January 2003, and the outside evaluator of the phonetics programme at the University of Utrecht (UiL-OTS), March 2003.

I was the co-organiser (with G. J. Docherty) of the Second Conference on Laboratory Phonology in Edinburgh in July 1989. This conference was a sequel to a conference held in June 1987 at Ohio State University and served to establish a continuing international biennial conference series. Until 1999 I remained a member of the overall organising committee. In 2010 this informal

committee was superseded by a legally established Association for Laboratory Phonology, of which I was a founding member and the first President (2010-2014).
